### OUTFITTER AGREES TO SUPPLY:

Guide services, caping and salting of trophies, all meals, lodging and equipment during hunt, transportation from Prince George to hunting camps and return with meat and trophies. Fishing is included at no extra charge but you must have a license.

### HUNTER AGREES TO SUPPLY:

Rifle, ammunition, sleeping bag, meat sacks, licenses, personal gear, transportation to Prince George.

HUNTERS ARE ASKED TO LIMIT THEIR BAGGAGE TO 60 LBS, PLUS RIFLE AND AMMUNITION. AN EXTRA CHARGE WILL BE CHARGED FOR EXCESS WEIGHT.

A deposit of 33% is required to book a hunt. On all fall hunts, a further 1/3, plus license and tag funds, is due on June 15 of year hunt is to take place. Balance due upon arrival in camp. Final payment must be cash, certified or travelers cheque. All deposits are non-refundable, but a client may appoint a substitute.
